# 2008 Archbishop Alter Varsity Football DVD Game Copies

## Terms of Service

### Type of Media

All DVD copies will be provided on DVD-R type media.  
Please consult your DVD manual for compliance to DVD-R media.

### Game DVD Distribution

If ordering all 10 regular season game DVDs, unless informed otherwise, you will have a standing order to purchase all playoff game film copies as ordered for the regular season. Entire 10-game orders will receive all playoff games at the price of \$15 each per DVD with invoices being sent after the last game played, due payable upon receipt.

Unless individually arranged differently, DVD game film copies will be distributed through Coach Domsitz. Delivery will be at "Films Night" following each game, when possible. If you are unable to pick up your copy at films night, contact Coach Domsitz, he will be given all DVDs not distributed that night.

### COPYING AGREEMENT

There are exact and certain circumstances under which the copying of Tom Suttman-produced video footage and DVDs will be permitted:

It is understood that persons purchasing game film copies on DVD may want and/or need to make copies of the game film copies provided.

With payment for the purchase of any and all 2008 Alter Varsity Football game film copies, and any other 2008 Alter Varsity Football videos provided by Tom Suttman, the following rules apply to the copying of the video(s) purchased or provided:

#### Acceptable Copying:

1. College recruitment:  
Any footage that Tom Suttman makes available can be, and is encouraged to be, used to help secure advancement to colleges. This includes permission to persons and companies, other than Tom Suttman, to use the game footage in the production of college recruitment highlight videos.
2. Personal archival:  
Any footage that Tom Suttman makes available may be duplicated for personal archival purposes.
3. Other team related purposes agreed to by Coach Domsitz.

#### Unacceptable Copying:

1. Resale. No copies of Tom Suttman footage may be made to be re-sold.
2. Gifts, broadcast or for any other use without the authorization of Tom Suttman.
3. Internet posting. Video from Tom Suttman may NOT be posted on the Internet, in any form or in any forum, either during the 2008 season or after, without the authorization of Tom Suttman, except when the footage is posted on a website that promotes the college recruitment of a player.

Persons violating this agreement will forfeit any DVDs not yet delivered, any and all funds related to the original purchase of the DVDs, in addition to being subject to any subsequent legal action that applies to violating this agreement. Coach Domsitz will be notified of any and all known copy violations.
